- 4. **Management Department**, West Guwahati Commerce College and **History Department** Kanya Mahavidyalaya, Geetanagar, Guwahati may jointly organise field trip, excursion, field survey, research activity, cultural programme etc.
- 5. To organise extension education programmes in collaborative mode for the benefits of students.
- 6. To utilise the library resources and art in education of both the college by students and teachers.
- 7. The students will be made to comply with the rules of both the institutions.

Operational Aspects

The terms of such mutual cooperation and necessary budget for each specific programme and activity that is implemented under the terms of this MOU shall be mutually discussed and agreed upon in writing by both parties prior to the particular programme or activity and the terms of such programme shall be negotiated whenever required.

Scope of Cooperation

The areas of cooperation include subject to mutual consent, any programme offered at either institutions as felt desirable and feasible on either side and that both sides feel can contribute to the fostering and development of the cooperative relation between the two institutions.

This Memorandum of Understanding (MOU) shall remain force for a period of five years from the date it is signed by appropriate officials of the two institutions. It may further be extended or emended with the written agreement of both parties.

The MOU may be terminated by either party subject to the delivery of two months advance notice, in
