Operational Aspects

The terms of such mutual cooperation and necessary budget for each specific programme and activity that is implemented under the terms of this MOU shall be mutually discussed and agreed upon in writing by both parties prior to the particular programme or activity and the terms of such programme shall be negotiated whenever required.

Scope of Cooperation

The areas of cooperation include subject to mutual consent, any programme offered at either institutions as felt desirable and feasible on either side and that both sides feel can contribute to he fostering and development of the cooperative relation between the two institutions.

This Memorandum of Understanding (MOU) shall remain force for a period of five years from the date it is signed by appropriate officials of the two institutions. It may further be extended or emended with the written agreement of both parties.
